NEW RESIGN POLICY (AS OF APRIL 2010)

YOU MUST RESIGN ON THE SECOND TUESDAY OF EACH MONTH

OFFICE HOURS: 8AM-5PM M-F

YOU MAY RESIGN IN PERSON, BY FAX, EMAIL AT WWW.REALJOURNEYMAN.COM, OR SEND A POST CARD TO OUR ADDRESS LISTED ABOVE.

YOUR RESIGN MUST INCLUDE YOUR NAME, UNION CARD NUMBER, REGISTRATION NUMBER, AND HOME LOCAL NUMBER.

OUR CALL-IN BID SYSTEM WILL REQUIRE THAT YOU CALL BETWEEN THE HOURS OF 5:30PM UNTIL 8:00 AM ANY DAY OF THE WEEK TO HEAR WHAT JOBS, IF ANY, ARE AVAILABLE. IF YOU CHOOSE TO BID ON A JOB, PLEASE LEAVE YOUR NAME, PHONE NUMBER AND REGISTRATION NUMBER AND PLEASE SPEAK CLEARLY. BE SPECIFIC ON THE JOB YOU ARE INTERESTED IN WHEN LEAVING YOUR MESSAGE, UNLESS YOU ARE INTERESTED IN ALL WE MAY HAVE LISTED, JUST SIMPLY SAY YOU ARE INTERESTED IN THEM ALL. KEEP IN MIND THAT THE JOBS LISTED WILL HAVE 48 HOURS BEFORE MEN ARE EXPECTED TO BEGIN WORK. FOR EXAMPLE: JOBS LISTED ON MONDAY WILL BE EXPECTED TO WORK ON WEDNESDAY. CALL BACKS WILL BE MADE BETWEEN 9AM AND 11AM THE FOLLOWING DAY. THE POSITIONS THAT RECEIVE ANY JOB WILL BE POSTED THAT EVENING ON THE JOB LINE AND POSTED ON LINE AT THE REALJOURNEYMAN SITE FOR YOUR VIEWING. ONLY LOCAL 668 MEMBERS WILL BE ABLE TO VIEW THE BOOK I POSITIONS. *SPECIAL NOTE* ALL SHORT CALLS ARE A TOTAL OF 14 CALENDAR DAYS OR LESS. APPLICANTS WILL BE RESTORED TO THEIR APPROPRIATE PLACE ON THE BOOK WHEN RETURNING FROM A SHORT CALL WHEN TERMINATION IS THROUGH NO FAULT OF THEIR OWN.
